BID SECURITY

There will be no bid bond required for this project.

HOLDING OF BIDS

No Bid shall be withdrawn after the opening of the Bids without the consent of the Owner, for a period of ninety (90) days after the scheduled time of closing Bids.

PREVAILING WAGE

The Contractor to whom an award shall be made pursuant to this procurement shall be subject to all applicable Federal and State laws and regulations, including but not limited to the Illinois acts commonly known as the Illinois Prevailing Wage Act (IL Rev. Sta. Ch. 48, Secs. 2201-2207).

BONDS

A payment and performance bond is required in connection with this project. The payment bond shall specifically provide that the Principal must pay all sums of money due or to become due for any labor in accordance with the Illinois Prevailing Wage Act, (IL Rev. Stat. Ch. 48, Sec. 39(s)-1-12).

AWARD OF CONTRACT

The Owner reserves the right to reject any Bid for failure to comply with all requirements of this notice or any of the Bidding Documents; however, it may waive any minor defects or informalities at its discretion. The Owner further reserves the right to reject any and all Bids or to award a contract which in its judgment is in the best interest of the Owner.
